The college administration will ensure that sufficient qualified teaching faculty, non-teaching staff, hospital staff and other requirements as per the provision of HCC (MSR), 2013; Regulations are in position before the admission of the first batch of students in the 1<sup>st</sup> professional BHMS course is made, under intimation to the Central Government and CCH.

The college has to develop the requisite infrastructure for 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> BHMS course well in time as per the CCH norms which will be verified and reported by the CCH at least three months before the start of next professional and accordingly, the permission for taking admissions in subsequent academic session will be issued.

4. The college administration may take up the matter for recognition of the qualification under section 13(1) of the HCC Act, 1973 at that time when the first batch of students admitted against this course appears for the first final professional examination of the said course.
