Sir,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it, under NCH Act 2020. As per section 59 (2) of NCH Act, 2020, following has been stated:

“Notwithstanding the repeal of the Homoeopathy Central Council Act 1973, the educational and medical standards, requirements and other provisions of the Homoeopathy Central Council Act, 1973 and the rules and regulations made thereunder shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made thereunder: Provided that anything done or any action taken as regards the educational and medical standards and requirements under the enactment under repeal and the rules and regulations made thereunder shall be deemed to have been done or taken under the corresponding provision of this Act and shall continue in force accordingly unless and until superseded by anything or by any action taken under this Act”.

As per provision in the Act, Medical Assessment and Rating Board for Homoeopathy has been constituted with the mandate to grant permission to the existing and new medical institution of Homoeopathy. Accordingly, it is to inform you that all the relevant documents submitted by your college in Part-1 proforma were examined by the Medical Assessment and Rating Board.

2. On careful consideration of the report, the Medical Assessment and Rating Board has arrived at the following conclusion :-

That the applicant has set up a Homoeopathic Medical College with the component of staff, infrastructure, equipment and instruments and other facilities where as the College has to take certain time bound steps to implement Minimum Standard Requirements of the Homoeopathy College and attached Hospital as prescribed by the National Commission for Homoeopathy for conducting BHMS course in Homoeopathy. The deficiencies observed are:

I. Discrepancies in engagement of Staff. The anomalies in engagement of the staff may be rectified / justified and reported to the Medical Assessment and Rating Board in the compliance report

- A. Dr. Kishor Kawalu Mendhe, MD (Hom), Reader/Associate Professor, Anatomy: Join on 1.11.2019, Previous Experience From 1-5-2017 to 30-10-2019 is of Associate Professor. No Experience of Lecturer Provided in Affidavit.
- B. Dr. Samir Mukund bhaiThakkar, MD (Hom), Professor, Homoeopathic Materia Medica: Affidavit provided as Lecturer/Assistant Professor, Homoeopathic Materia Medica.
- C. Dr. Amrish kumar Thakorlal Parikh, MD (Hom), Professor, Pathology: Joined on 13.12.2019, Previous Experience of Lecturer/Reader, not provided in affidavit.
- D. Dr. Bhasmang Pradyuman Trivedi, MD (MED), Reader/Associate Professor, Practice of Medicine: Join on 1.11.2017, Previous Experience as Lecturer is 2 year 2 month, (1-1-2005 to 5-3-2007). No other Experience Provided.
- E. Dr. Mayur Vanmali das Ganatra, MS (ORTO), Reader/Associate Professor, Surgery: Joined on 01.09.2020, Previously Joined on 1.5.2005 at age 45 Years 11 months. No other Experience Provided.
- F. Dr. Pareshh Nagindas Seth, MD (Hom), Reader/Associate Professor, Obstetrics/Gynecology: Join on 01.04.2017, Previous Experience as Lecturer is 3 year 9 month (10-01-2005 to 15-10-2008). No other Experience Provided.
- G. **Guest Faculty:**
 - i. Dr. Kumkum P Kalra, Guest Faculty, Materia Medica: Join on 1.1.2020, Previous Experience is of Associate Professor 1.7.2014 to 31.08.2017, No other Experience Provided.
 - ii. Mr. Dushyant D Desai, Guest Faculty, Pathology: Join on 16.10.2017, No Previous Experience Provided.

II. Teaching Department: Physiology and Pathology Lab technician mentioned as 01 each in staff information but only 01 available in the list with qualification mentioned as B.Sc.

III. Miscellaneous:

- A. Salary bank statement- Provided, salary through bank transfer.
- B. EPF/PF /ESI deductions of teachers, non teaching staff & hospital staff- ESI not deducted as not applicable as per ESI office letter.
- C. EPF Not deducted, as not opted by the employees as per the CA letter.
- D. Form-16 of teachers, non-teaching staff & hospital staff- TDS not deducted as not opted by the employees as per the CA letter.

3. After considering the provisions of section 12C (1) of Homoeopathy Central Council Act, 1973 and HCC(MSR) Regulations, 2013, **Permission of the Medical Assessment and Rating Board is issued to Ananya College of Homoeopathy, KIRC Campus, Ahmedabad- Mahesana Highway, Kalol, Dist. Gandhinagar-382721, Gujarat for continuing admissions for I-BHMS with 100 seats for the academic session 2021-22.** The College Principal is directed to fulfill the deficiencies within three months and an affidavit in this regard may be submitted to the Medical Assessment Board within a period of one week.


4. All admissions in Under Graduate course shall be through NEET only. It is further informed that, minimum 15% of seats of the permitted intake capacity of BHMS course shall be treated as All India quota. The counseling for seats under All India quota shall be conducted by respective counseling Authority of State / UT Government as designated by the Central Government and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of that State/UT.

The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted thereunder.

5. The category wise list of selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board as per rules.

6. The college has to comply with the full requirements of HCC (MSR) Regulations, 2013 for conducting the course. All deficiencies observed and mentioned above which affects the performance of the academic Institution, through which College fails to fulfill the statutory requirements, has to be rectified within three months time from the date of issue of this permission letter and the compliance report shall be submitted by the college to Medical Assessment and Rating Board accordingly. Subsequently, the Board shall verify the compliance well in time and may conduct Online/Physical inspection for verification of compliance as per the HCC (MSR) Regulation, 2013 and will consider admissions for the academic year 2022-23.
