Sir,

As Central Government by notification, constituted a Commission, to be known as the National Commission for Homoeopathy, to exercise the powers conferred upon, and to perform the functions assigned to it under NCH Act, 2020. Medical Assessment and Rating Board for Homoeopathy (MA&RBH) has been constituted with the mandate to grant permission for student intake to the existing and new medical institution of Homoeopathy.

- Accordingly, it is to inform that Part-1 proforma and all the relevant documents submitted by your college in were examined as per the existing regulations.
- After considering the provisions of NCH Act, 2020 and its relevant regulations, permission of the Medical Assessment and Rating Board is granted to Ananya College of Homoeopathic, Kirc Campus, Mehsana Ahmedabad Highway, Kalol, Gujarat-382721 for conducting UG (B.H.M.S.) Course with intake Capacity of 100 seats for the academic session 2022-23.
- All admissions in Under Graduate (BHMS) course shall be through 'National Eligibility Entrance Test (NEET)' only. It is further informed that, minimum 15% seats of permitted intake capacity of BHMS course shall be treated as All India Quota. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board for Homoeopathy as per rules and the penalty as decided will be imposed in such cases.
- The counselling for seats under All India quota shall be conducted by respective counselling 5. Authority of State/ UT Government as designated by the Central Government and counselling for the remaining 85% seats or as the case may be, shall be conducted by the concerned Counselling Authority of that State / UT. 100% Under Graduate of the permitted intake capacity shall be treated as all India quota for Deemed University as they are All India in nature. The Counselling of seats under All India Quota shall be conducted by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed.
- The permission of the college stands withdrawn if the college fails to comply with the aforesaid 6. direction of the Central Government for All India quota or the student admitted there under. The category wise list of students admitted may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed.
